The purpose of this journey level position is to install, repair, configure, operate and maintain video surveillance, access control, and various communications systems and associated network servers and devices.

Examples of Duties

- Maintains and operates video security and communications systems by installing, configuring, maintaining, repairing, and upgrading systems. Evaluates systems for safety, cost, effectiveness, efficiency, and reliability, analyzing, troubleshooting and resolving problems with assigned systems, and providing analytical and technical support in the design, construction, installation, operation, maintenance, and repair of large, complex, and geographically diverse security and communication equipment.
- Serves as a project lead and departmental liaison on various security and communication related procurements, installation, and construction projects, preparing proposal and bid documents for purchase of communications and security related equipment or services, coordinating the work of contracted employees, and maintaining effective liaison with suppliers, contractors and departments.
- Manages information and administrative tasks by serving as a liaison to internal and external requests for information, preparing and presenting progress and status reports, and maintaining knowledge currency with industry technology advancements.

Minimum Qualifications
